FGL has approved the extension of the waiver for all products for a period of 6 months until September 2024.</p> <p>The FGL Board (or a delegate of the FGL Board) reviews the need for the waiver periodically and can revoke the waiver (on a product-by-product basis) as needed.</p> <p>All market participants will be provided with 3 months advance notice of any change to the application of the waiver to any product.</p>
Basis	The basis for the waiver remains unchanged and relies on sufficient participation and/or liquidity levels in any product.
